HUMAN FRONTIERS RESEARCH PROGRAM

HFSP Research Grants support innovative basic research into fundamental biological problems with emphasis placed on novel and interdisciplinary approaches that involve scientific exchanges across national and disciplinary boundaries.

Research grants are provided for teams of scientists from different countries who wish to combine their expertise in innovative approaches to questions that could not be answered by individual laboratories. Preliminary results are not required and applicants are expected to develop new lines of research through the research collaboration.

The amount paid depends on the number of team members which normally should be 2 - 4. Two members from the same country are acceptable if the team can convince the reviewers that both members are essential for the success of the project.

Two types of Grant are available: Research Grants - Early Career and Research Grants - Program.

- Submission of Letters of Intent: **28 March 2024** (updated for each cycle)

VISEGRAD GRANTS -VISEGRAD GRANT, VISEGRAD GRANT+, STRATEGIC GRANT

Visegrad Fund annually allocates approximately EUR 10 million to hundreds of Visegrad cooperation projects and mobility programs across Central and Eastern Europe.

The project should be implemented in a consortium

Visegrad grant- The international consortium should be composed rom at least 3 V4 countries OR Bilateral cross-border cooperation of at least 2 organizations from 2 neighboring V4 countries also qualify for support with projects taking place within a 40-km radius from the border and focusing on a local issue

Visegrad grant+- active involvement of at least 3 V4 countries and 1 entity from the Eastern Partnership region (EaP) or the Western Balkans countries (WB) at minimum (3xV4 + 1xEaP/WB format). However, if the applicant is from one of the EaP or WB countries, it is enough to involve two V4 countries in the project consortium, if another EaP/WB country is also involved (2xV4 + 2xEaP/WB format).

Strategic grant- Projects must be developed by organizations from all V4 countries

SWISS NATIONAL SCIENCE FOUNDATION- MULTILATERAL ACADEMIC PROJECT

MAPS promotes knowledge circulation by providing cross-border collaboration opportunities with Bulgaria, Croatia, Hungary, Poland and Romania.

MAPS will be implemented through Joint Research Projects that are aimed at promoting collaborative projects with clearly defined goals, involving at least one applicant based in Switzerland and two to five additional applicants from two to five of the participating EU-13 countries. Research is carried out at the respective research facilities involved, while reciprocal visits and short stays may also be supported.

The maximum amount of funding for each team in each country is 350,000 francs for four years.

MEDIA LITERACY

Allocation: 28,000,000 EUR

Est. date of publishing: 09/2024

The CROSS SECTORAL strand shall provide support to cross-cutting actions that support the news media sector, which shall promote media literacy in order to enable citizens to use, and develop a critical understanding of, the media and support knowledge sharing and exchanges on media literacy policies and practices. Support will encourage knowledge sharing and exchanges on media literacy policies and practices to enable the development of innovative cross-border media literacy initiatives and communities across Europe, in a continuously changing digital media landscape and taking into account current user behaviour among various age groups.

The following types of activities are eligible under this Call for proposals:

(1) Creation and/or distribution of multilingual and/or multicultural material, including interactive content to improve the digital capacities of citizens and their understanding of the media landscape and their resilience against disinformation.

(2) Development of materials for citizens and trainers targeting all or any age and societal groups.

(3) Development of innovative media literacy solutions fit for the future media landscape (the project can include prototypes, but not focus exclusively on ITdevelopment).

(4) Training activities for citizens and educators, including sharing of best practices across linguistic, state and cultural borders.

(5) Organisation of public events and/or workshops to raise awareness and share best practices.

(6) Community-led activities to tailor and make accessible the above-mentioned tools and materials.

Consortium composition:

Proposals must be submitted by a consortium of at least 3 applicants (beneficiaries; not affiliated entities), which complies with the following conditions: – minimum 3 independent entities from 3 different eligible countries – consortia may include profit and non-profit organisations (private or public), public authorities (national, regional, local), international organisations, universities and educational institutions, media organisations, research and technology institutions, and technology providers.

INNOVATION LAB

Objectives: Within the specific objective of promoting policy cooperation and innovative actions supporting all strands of the Programme, promoting a diverse, independent and pluralistic media environment and media literacy, thereby foresting freedom or artistic expression, intercultural dialogue and social inclusion, the priorities of the crosssectoral strand shall include: - to encourage innovative approaches to content creation, access, distribution, and promotion across cultural and creative sectors and with other sectors, including by taking into account the digital transition, covering both market and non-market dimensions;

Themes and priorities (scope):

The Cross Sectoral strand shall support the 'creative innovation lab', which shall:

(a) encourage new forms of creation at the crossroads between different cultural and creative sectors, for example through experimental approaches and the use of innovative technologies;

(b) foster innovative cross-sectoral approaches and tools which shall, where possible, encompass multilingual and social dimensions to facilitate the distribution, promotion and monetisation of, and access to, culture and creativity, including cultural heritage.

COST- EUROPEAN COOPERATION IN SCIENCE & TECHNOLOGY

COST funds interdisciplinary research networks.

The funding a COST Action receives covers the expenses of networking activities rather than research. As such is used to organise and fund events, Short-term Scientific Missions, Training Schools, communication activities, and virtual networking tools. An estimated €125,000 is made available for a COST Action in its first year and an average of €150,000 per year for the other 3 years.

Deadline: 23. October 2024.

Participation in COST Actions has led to significant results and follow-up in terms of the number of proposals submitted for collaborative research in Framework Programmes, with a success rate which more than triple the average success rates for these programmes (37% success rate). By funding networking, COST acts as a pre-portal for further research and innovation funding such as Horizon Europe, the European Union's Framework Programme for Research and Innovation.

WORLDWIDE CANCER RESEARCH

The goal is to support research that seeks to answer the difficult questions in cancer biology. WCR is looking for innovative and truly novel ideas that have the potential to revolutionise our understanding of cancer and how to beat it.

They award project grants of 12 to 36 months in length to support basic, fundamental or translational research into the prevention, diagnosis or treatment of cancer. They do not prioritise any field of research within this;

Welcome research that draws on epidemiological, behavioural and clinical data to provide a starting point for a new avenue of research. Multidisciplinary or discipline-hopping projects are encouraged where this helps stimulate innovation.

The principal investigator on the application must be a suitably qualified researcher (minimum of PhD followed by three years research experience, or equivalent qualification or research experience).

The WCR awards grants to principal investigators based at any not-for-profit research institute in the world.

The maximum budget allowed is £275,000, but it should be noted that most of the three-year grants we award have a budget of around £200,000.

The 2024 Grant Round is now open. The submission period will open on the 29th February, and the deadline for submitting your application is **5pm on April 2nd 2024**.

FEBS-FELLOWSHIPS

The FEBS Fellowships programme is a highly competitive and respected programme for earlystage researchers. Most of its schemes over the years have supported graduate students and earlycareer researchers in the molecular life sciences in the FEBS area to move to and carry out a period of research in a lab in a different FEBS country, thus broadening their experience and training, giving access to additional research techniques and expertise, and facilitating international collaboration.

Types of FEBS fellowships:

- Short-Term Fellowships are for scientists who have obtained their PhD degree within the past six years, and PhD students who have at least one published paper as a main author in an international scientific journal. Applications may be made at any time, but an application should be submitted at least three months before the proposed starting date
- Summer Fellowships are for PhD students and Master's students. Apply by 1 April each year (the call normally opens in February).
- **Collaborative Developmental Scholarships** are for PhD students or early/mid-career PhD holders in certain disadvantaged FEBS countries. Applications may be made at any time, but an application should be submitted **at least three months before the proposed starting date**.

EMBO- SCIENTIFIC EXCHANGE GRANT

Supporting international collaborations, enabling transfer of expertise. EMBO Scientific Exchange Grants are awarded for research exchanges between laboratories in EMBC Member States, Associated Member States or Cooperation Partners. The grants are not awarded for exchanges between two laboratories within the same country.

The grants are intended for visits of one week (7 days) up to three months (90 days).

Applicants must be active researchers at any stage in their career with a minimum of one year of research experience at the PhD student level, or equivalent at the time of application.

HUMAN FRONTIERS RESEARCH – POSTDOCTORAL FELLOWSHIP

The HFSP fellowship program supports proposals for frontier, potentially transformative research in the life sciences. Applications for high-risk projects are particularly encouraged. The projects should be interdisciplinary in nature and should challenge existing paradigms by using novel approaches and techniques. Scientifically, they should address an important problem or a barrier to progress in the field.

HFSP postdoctoral fellowships encourage early career scientists to broaden their research skills by moving into new areas of study while working in a new country.

Two different fellowships are available:

Long-Term Fellowships (LTF) are for applicants with a PhD on a biological topic who want to embark on a novel and frontier project focussing on the life sciences.

Cross-Disciplinary Fellowships (CDF) are for applicants who hold a doctoral degree from a nonbiological discipline (e.g. physics, chemistry, mathematics, engineering or computer sciences) and who have not worked in the life sciences before.
