BIODIVERSA+- BIODIVERSITY AND TRANSFORMATIVE CHANGE

BiodivTransform will aim for interdisciplinary, transdisciplinary, and/or cross-sectoral research and innovation projects to identify, analyse, and comprehend transformation processes that may halt and reverse biodiversity decline.

It should generate knowledge to safeguard biodiversity and ecosystems, as well as the benefits these may provide to people, through transformative change to mitigate and reverse biodiversity threats.

Projects will be expected

- to demonstrate academic excellence with potential for societal and policy impact regarding biodiversity, aiming to connect science, society, policy, and practices for transformative change.
- to have a holistic approach and to be transnational, inter- and transdisciplinary and mobilise as needed natural sciences, technical sciences, social sciences, humanities, and art.

For both steps, the **international added value** must be clearly presented.

The detailed assessment criteria to be used for this call will be published at the official launch of the call in September.

Indicative timeline:

- 10. September 2024- call will be launched
- early November 2024- deadline of the pre-proposal
- early April 2025- deadline of the full proposal

DRIVING URBAN TRANSITIONS - DUT Call 2024

The purpose of this Call for proposals is to support transnational research and/or innovation projects addressing urban challenges to help cities in their transition towards a more sustainable economy and functioning. The challenges are grouped into three themes called ‘Transition Pathways’: Circular Urban Economies, 15-minute City and Positive Energy Districts.

This is the third Call of the Driving Urban Transitions (DUT) Partnership, funded by the European Commission under the Horizon Europe Partnership scheme.

This Call is open to a very wide range of scientific disciplines, in social sciences and humanities and arts, in environmental, natural and technical sciences and applied fields, such as architecture, landscape architecture, urban design, design, art, spatial planning and policy development.

Each proposal must be submitted by a consortium consisting of at least three eligible Applicants from at least three different participating countries.

MSCA STAFF EXCHANGES

Objective of Staff Exchanges

The Staff Exchanges action funds short-term international and inter-sectoral exchanges of staff members involved in research and innovation activities of participating organisations. The aim is to develop sustainable collaborative projects between different organisations from the academic and non-academic sectors (in particular SMEs), based in Europe and beyond.

Exchanged staff benefit from new knowledge, skills and career development perspectives, while participating organisations increase their research and innovation capacities.

Who can apply for Staff Exchanges?

Staff Exchanges are open to international consortia of universities, research institutions, businesses, SMEs and other non-academic organisations. They need to include

- at least three organisations in three different countries, two of which need to be located in a different EU Member State or Horizon Europe Associated Country
- above this minimum, the participation of organisations from any country is possible
- if all participating organisations are from the same sector (academic or non-academic), at least one must be from a non-associated Third Country

Individual staff members are selected by their sending organisations to take part in the planned exchanges.

What does the funding cover?

Staff Exchanges projects can last up to four years. The grant funds the mobility of seconded staff members from one month to one year. Staff involved should return to their sending organisations after the secondment, to pass on their knowledge.

Staff exchanges between organisations in EU Member States or Horizon Europe Associated Countries are required to be between different sectors (academic or non-academic), except if they are interdisciplinary. For partnerships with non-associated Third Countries, exchanges within the same sector and the same discipline are allowed.

Staff funded by Staff Exchanges

- can be researchers at any career stage, from PhD candidates to postdoctoral researchers, as well as administrative, technical or managerial staff involved in research and innovation activities
- can be of any nationality
- must be engaged in, or linked to, research and innovation activities at their sending organisation for at least one month prior to the secondment
- should return to their sending organisation after the secondment, to pass on their knowledge and foster collaboration

Seconded staff receives

- a top-up allowance (for travel, accommodation, subsistence costs), which is on top of the salary paid by their organisation
- a special needs allowance, if applicable

In addition, funding is provided for

- research, training and networking activities
- management and indirect costs

MSCA DOCTORAL NETWORKS

The objective of Doctoral Networks is to implement doctoral programmes by partnerships of organisations from different sectors across Europe and beyond to train highly skilled doctoral candidates, stimulate their creativity, enhance their innovation capacities and boost their employability in the long-term.

Doctoral Networks implement doctoral programmes, by partnerships of universities, research institutions and infrastructures, businesses including SMEs, and other socio-economic actors from different countries across Europe and beyond. These doctoral programmes will respond to well-identified needs in various research and innovation areas, expose the researchers to the academic and non-academic sectors, and offer research training, as well as transferable skills and competences relevant for innovation and long-term employability.

Besides standard Doctoral Networks, incentives have been introduced to promote two specific types of doctorates as well.

1. Industrial Doctorates. They train PhD candidates who wish develop their skills and step outside academia, in particular in industry and business. Individual participants must be enrolled in a doctoral programme and jointly supervised by the academic and non-academic partners.
2. Joint Doctorates. They provide a highly integrated type of international, inter-sectoral and interdisciplinary collaboration in doctoral training leading to a joint doctoral degree or multiple doctoral degrees awarded by the participating institutions. PhD candidates must be enrolled in a joint programme and be jointly supervised.

Doctoral Networks are open to international consortia of universities, research institutions, businesses, SMEs and other non-academic organisations. They should include

- at least three independent legal entities, each established in a different EU Member State or Horizon Europe Associated Country and with at least one of them established in an EU Member State
- on top of this minimum, other organisations from any country in the world can also join
- specific conditions apply to Industrial and Joint Doctorates

As from 2022, resubmission restrictions will apply for applications that received a score below 80% the previous year.

Candidates wishing to apply for PhD positions under Doctoral Networks should apply to funded Doctoral Network projects by consulting their open vacancies advertised internationally, including on the EURAXESS portal.

The 2024 call is now open. **The call will close on 27 November 2024.**

The expected outcome is : The ERA Talents action aims to boost interoperability of careers in the academic and non-academic sectors and improve employability of R&I talents across sectors.

- The secondment may be split into several stays with one or several participating organisations, but cannot exceed 24months in total for the same staff member;
- There is no minimum duration of stay for the secondment;
- Open to researchers, innovators and other research and innovation talents (i.e. administrative, managerial and technical staff supporting R&I activities in their organisations) from any career stage

- The Coordinator of the consortium must come from a widening country. The consortium must include a minimum of 3 entities, 2 of which established in a widening country.

VISEGRAD GRANTS -VISEGRAD GRANT, VISEGRAD GRANT+, STRATEGIC GRANT

Visegrad Fund annually allocates approximately EUR 10 million to hundreds of Visegrad cooperation projects and mobility programs across Central and Eastern Europe.

The project should be implemented in a consortium

Visegrad grant- The international consortium should be composed from at least 3 V4 countries OR Bilateral cross-border cooperation of at least 2 organizations from 2 neighboring V4 countries also qualify for support with projects taking place within a 40-km radius from the border and focusing on a local issue

Visegrad grant+- active involvement of at least 3 V4 countries and 1 entity from the Eastern Partnership region (EaP) or the Western Balkans countries (WB) at minimum (3xV4 + 1xEaP/WB format). However, if the applicant is from one of the EaP or WB countries, it is enough to involve two V4 countries in the project consortium, if another EaP/WB country is also involved (2xV4 + 2xEaP/WB format).

Strategic grant- Projects must be developed by organizations from all V4 countries

MSCA POSTDOCTORAL FELLOWSHIPS

Postdoctoral Fellowships helps experienced researchers acquire new skills, develop their careers, and gain international, interdisciplinary, and inter-sectoral experience by working abroad. These prestigious fellowships are a stepping stone in researchers' careers, allowing them to carry out cutting-edge research and to cooperate with leading scientific teams and figures.

There are 2 types of Postdoctoral Fellowships:

1. European Postdoctoral Fellowships. They are open to researchers moving within Europe or coming to Europe from another part of the world to pursue their research career. These fellowships take place in an EU Member State or Horizon Europe Associated Country and can last between 1 and 2 years. Researchers of any nationality can apply.
2. Global Postdoctoral Fellowships. They fund the mobility of researchers outside Europe. The fellowship lasts between 2 to 3 years, of which the first 1 to 2 years will be spent in a non-associated Third Country, followed by a mandatory return phase of 1 year to an organisation based in an EU Member State or Horizon Europe Associated Country. Only

nationals or long-term residents of the EU Member States or Horizon Europe Associated Countries can apply.

Both types of fellowships may also include short-term secondments anywhere in the world during the fellowship (except during the return phase of a Global Fellowship).

In an effort to build bridges between the academic and non-academic sector, researchers can receive additional support to carry out a placement of up to 6 months in a non-academic organisation based in an EU Member State or Horizon Europe Associated Country. This placement needs to take place at the end of their fellowship.

Interested researchers submit an application together with a host organisation, which can be a university, research institution, business, SME or other organisation based in an EU Member State or Horizon Europe Associated Country. All disciplines are eligible for Postdoctoral Fellowships, including research areas covered by the Euratom Research and Training Programme.

MSCA4UKRAINE

The MSCA will also dedicate an additional €10 million to support displaced researchers from Ukraine through MSCA4Ukraine. Since 2023, the scheme has allowed 125 displaced researchers from Ukraine to train and work in 21 countries.

ERC GRANTS – ELIGIBILITY OF SWISS HOST INSTITUTIONS

Three of the ERC's upcoming grant competitions to be launched in 2024 will be open to researchers based in Swiss entities.

The European Commission's decision on eligibility for ERC calls has been taken in the context of the ongoing negotiations between the EU and Switzerland on a broad package of measures, which includes Switzerland's association to Union Programmes such as Horizon Europe. The decision goes beyond what the Commission committed to in the Common Understanding and is a clear sign of a goodwill in the negotiation process.

These transitional arrangements will allow for Swiss legal entities to be treated as being “entities established in Associated Countries” for the Starting Grant, Consolidator Grant and Synergy Grant calls for proposals in the forthcoming ERC work programme 2025.

As previously announced, the transitional arrangements apply to the Advanced Grant call under the ERC work programme 2024, which is currently open for the submission of proposals (deadline 29 August 2024). However, grant agreements for all of the above calls may only be signed with successful applicants if the association agreement with Switzerland applies at that time.
