INTERREG CENTRAL EUROPE – THIRD CALL

Call for peripheral and lagging areas

The call is open from 15 October to 10 December 2024.

Territorial challenges

The central Europe territory is characterised by structural differences and economic disparities between different types of regions, notably more advanced and industrialised areas (e.g. capital regions, metropolitan areas) and deprived areas (e.g. peripheral areas including inner peripheries, rural areas which are lagging behind). The latter are characterised by lower competitiveness and shrinking populations, and they face many different challenges in relation to economic development, connectivity, demographic change and social cohesion. Furthermore, there are significant disparities in the quality of governance and public services.

Targeted territories

With this call we want to **unlock the development potentials of peripheral and lagging areas**. Projects shall deliver local and regional solutions tailored to the specific challenges of these places in line with the principles of the Territorial Agenda (TA) 2030, with lessons learned from related pilot actions serving as insights for project applicants.

In order to qualify for the territorial focus of the call, **areas to be targeted by projects have to show one or more of the following characteristics:**

- Low economic potential;
- Poor access to services of general interest, often affected by demographic change;
- Lack of relational proximity, decline in significance, influence or connectivity.

These characteristics of peripherality and lagging areas are of qualitative nature and **there is no specific list or map of eligible regions to be targeted** by projects. Targeted areas may be rural but may also include urban areas which are lagging behind in terms of socio-economic development. Their scale and size can vary depending on the project goals, e.g. ranging from local

neighbourhoods (e.g. suburbs), city districts, villages and rural communities, small-or medium-sized towns or entire regions that are suffering from peripherality or that lag behind.

Thematic focus

The call will be thematically focused and be **open for proposals in four programme specific objectives (SOs)**:

- SO 1.2: Strengthening skills for smart specialisation, industrial transition and entrepreneurship
- SO 2.5: Greening urban mobility
- SO 3.1: Improving transport connections of rural and peripheral regions
- SO 4.1: Strengthening governance for integrated territorial development

Projects shall promote good governance through inclusive and participatory processes, on supporting socio-economic transformation by developing human capital and improving connectivity and governance in the concerned territories.

BILATERAL CALLS- SLOVAKIA-HUNGARY 2024

Within the public call SK-HU 2024, project proposals from all research and development areas can be submitted. The aim of bilateral cooperation projects is to establish new or intensify the existing scientific and technological cooperation, using mainly the following instruments:

- preparation of joint international projects;
- preparation of joint publications and other outputs;
- active participation in conferences, organizing the joint scientific events;
- mutual use of instrumentation and laboratory techniques;
- gathering the research materials;
- involvement of Ph.D. students and/or young R & D staff (aged under 35).

The total amount of funds maximum of EUR 4,700 for the whole project duration and a maximum of EUR 2,350 per a calendar year of project.

NATO SCIENCE FOR PEACE AND SECURITY

The NATO Science for Peace and Security (SPS) Programme promotes dialogue and practical cooperation between NATO member states and Partner countries based on scientific research, technological innovation and knowledge exchange

Applications submitted to the SPS Programme must:

1. Contribute toward NATO's strategic objectives and have a clear link to security;
2. Address at least one of the SPS Key Priorities;
3. Be developed jointly by scientists or experts from at least one NATO member country and one eligible Partner nation.

RESEARCH AND ANALYSIS INTO JURISPRUDENCE ON INTERNATIONAL PROTECTION

The funded project is expected to enrich the collection of jurisprudence stored in the [EUAA Case Law Database](#), to enhance access to relevant asylum case law and ultimately strengthen the effective implementation of the Common European Asylum System (CEAS). It will increase information exchange on emerging issues in asylum appeals, and the organisation and functioning of appeal procedures in EU+ countries (*i.e.*, EU Member States, Iceland, Norway, and Switzerland).

The grant is aimed at **higher education institutions** (*i.e.*, eligibility criterion) with **asylum or human rights expertise**.

The project entails:

1. Collecting relevant publicly available jurisprudence on asylum and providing descriptive summaries in English to be included in the EUAA Case Law Database, while following the [EUAA methodology](#).
2. Registering a minimum of 300 cases in the EUAA Case Law Database.
3. Drafting a minimum of 2 analytical reports on specific topics in asylum case law.

MSCA DOCTORAL NETWORKS

The objective of Doctoral Networks is to implement doctoral programmes by partnerships of organisations from different sectors across Europe and beyond to train highly skilled doctoral candidates, stimulate their creativity, enhance their innovation capacities and boost their employability in the long-term.

Doctoral Networks implement doctoral programmes, by partnerships of universities, research institutions and infrastructures, businesses including SMEs, and other socio-economic actors from different countries across Europe and beyond. These doctoral programmes will respond to well-identified needs in various research and innovation areas, expose the researchers to the academic and non-academic sectors, and offer research training, as well as transferable skills and competences relevant for innovation and long-term employability.

Besides standard Doctoral Networks, incentives have been introduced to promote two specific types of doctorates as well.

1. Industrial Doctorates. They train PhD candidates who wish develop their skills and step outside academia, in particular in industry and business. Individual participants must be

enrolled in a doctoral programme and jointly supervised by the academic and non-academic partners.

2. Joint Doctorates. They provide a highly integrated type of international, inter-sectoral and interdisciplinary collaboration in doctoral training leading to a joint doctoral degree or multiple doctoral degrees awarded by the participating institutions. PhD candidates must be enrolled in a joint programme and be jointly supervised.

Doctoral Networks are open to international consortia of universities, research institutions, businesses, SMEs and other non-academic organisations. They should include

- at least three independent legal entities, each established in a different EU Member State or Horizon Europe Associated Country and with at least one of them established in an EU Member State
- on top of this minimum, other organisations from any country in the world can also join
- specific conditions apply to Industrial and Joint Doctorates

As from 2022, resubmission restrictions will apply for applications that received a score below 80% the previous year.

Candidates wishing to apply for PhD positions under Doctoral Networks should apply to funded Doctoral Network projects by consulting their open vacancies advertised internationally, including on the EURAXESS portal.

The 2024 call is now open. **The call will close on 27 November 2024.**

WISEGRAD GRANTS - VISEGRAD GRANT, VISEGRAD GRANT+, STRATEGIC GRANT

Visegrad Fund annually allocates approximately EUR 10 million to hundreds of Visegrad cooperation projects and mobility programs across Central and Eastern Europe.

The project should be implemented in a consortium

Visegrad grant- The international consortium should be composed from at least 3 V4 countries OR Bilateral cross-border cooperation of at least 2 organizations from 2 neighboring V4 countries also qualify for support with projects taking place within a 40-km radius from the border and focusing on a local issue

Visegrad grant+- active involvement of at least 3 V4 countries and 1 entity from the Eastern Partnership region (EaP) or the Western Balkans countries (WB) at minimum (3xV4 + 1xEaP/WB format). However, if the applicant is from one of the EaP or WB countries, it is enough to involve two V4 countries in the project consortium, if another EaP/WB country is also involved (2xV4 + 2xEaP/WB format).

Strategic grant- Projects must be developed by organizations from all V4 countries

The LIFE Calls for proposals 2024 have been published on the [Funding & tender opportunities portal](#) on 18 April 2024.

Subprograms:

The **Nature and Biodiversity** sub-programme will aim at the protection and restoration of Europe's nature and halting and reversing biodiversity loss. Thus, the LIFE Nature and Biodiversity sub-programme will continue to fund nature conservation projects, in particular in the areas of biodiversity, habitats and species. It will support projects that contribute to the implementation of the EU [Birds](#) and [Habitats](#) directives, and in particular the development and management of the [Natura 2000 network](#), and the [IAS Regulation](#), and will support achieving the objectives of the [EU's biodiversity strategy for 2030](#), part of the [EU Green Deal](#).

SNSF- SWISS POSTDOCTORAL FELLOWSHIP

Switzerland is considered a non-associated third country in the 2024 calls for projects in Horizon Europe (work programme 2023-2025) and related programmes and initiatives. This year, on behalf of the Swiss Confederation, the SNSF is launching a new call under the transitional measure SNSF Swiss Postdoctoral Fellowships for people of all nationalities who were aiming to apply for a Marie Skłodowska-Curie Postdoctoral Fellowship (MSCA PF).

In the three previous SNSF Swiss Postdoctoral Fellowships calls, the success rate was between 7 and 18%

the scheme is open to all research disciplines and topics.

This funding scheme will offer applicants with a PhD and no more than eight years of postdoctoral experience a position at a non-commercial research institution in Switzerland for 12-24 months.

The grant includes the postdoctoral fellow's salary with social security contributions, financial contributions to research, and conference costs.

- Applicants must be affiliated with an institution such as a university or museum. We do not give directly to individuals.
- Resubmittals are welcome and encouraged.
- If you have received a Leakey Foundation grant in the past, you must complete all reporting requirements before receiving a new one.

Eligible expenses

- The grant can only be used for expenses directly related to your research and essential to the project such as travel, living expenses during fieldwork, supplies, and research expenses.
- Aid is not offered for salary and/or fringe benefits of applicant or senior project personnel, child care, equipment, travel to meetings, institutional overhead, publication costs, or institutional support.

MOPGA FELLOWSHIP FOR EARLY CAREER RESEARCHERS

This eighth Make Our Planet Great Again (MOPGA) call for applications is intended to welcome at least **60 early career researchers wishing to carry out their research in France**. The program is funded by the French Ministry for Europe and Foreign Affairs, in collaboration with the French Ministry for Higher Education and Research, and implemented by Campus France.

The MOPGA 2025 Visiting Fellowship Program for Early Career Researchers will support researchers working on topics:

- Earth systems
- Climate change and sustainability
- Energy transition
- Societal challenges of environmental issues
- Human, animal and ecosystem health as part as a "One Health" approach.

WHO MAY APPLY?

- **Foreign researchers** holding a doctoral degree for less than 5 years

- No nationality restrictions (except France)
- **60 fellowships** will be awarded for a **12-month period** from September 2025

The grant:

- **Monthly allowance of 2,500 euros**
- Moving allowance of 500 euros
- Health Insurance plan covering civil liability and repatriation assistance until the MOPGA Fellow's registration to the French Social Security Scheme
- Complementary Health Insurance plan covering civil liability and repatriation assistance once the Social Security registration process is effective.

ELIGIBILITY

Individuals fitting the following criteria are eligible to apply:

- Applicants who do **NOT** hold French citizenship
- Foreign researchers holding a doctoral degree for less than 5 years (must have passed their thesis defense between December 2019 and December 2024)

ZONTA INTERNATIONAL AMELIA EARHART FELLOWSHIPS

Zonta International encourages and supports women to expand their horizons by pursuing degrees and careers in aerospace engineering and space sciences. In the program's 86-year history, Zonta has awarded 1,764 Amelia Earhart Fellowships, totaling more than US\$11.9 million, to 1,335 Fellows from 79 countries. It is anticipated that up to 30 Fellowships of US\$10,000 each will be awarded in 2025.

ELIGIBILITY

Women of any nationality pursuing a Ph.D./doctoral degree who demonstrate a superior academic record and who are conducting research applied to aerospace engineering or space sciences are eligible. It is imperative that students be registered in a full-time Ph.D./doctoral program and have completed at least one year of that program or have received a master's degree in an aerospace-applied field at the time the application is submitted. Applicants must not graduate from their Ph.D. or doctoral program before April 2026. Please note that post-doctoral research programs are not eligible for the Fellowship.

Note that three (3) recommendations from university professors (or supervisors), copies of official transcripts, and verification of enrollment for the 2025 Amelia Earhart Fellowships **must be submitted by 15 November 2024** to be considered.

BAYHOST

For the the academic year 2025/26, the Free State of Bavaria will once again be awarding one-year scholarships to graduates (with appropriate citizenship) from Bulgaria, Croatia, Czechia, Hungary, Poland, Romania, Russia, Serbia, Slovakia and Ukraine. The scholarship is intended to finance **postgraduate studies** (i.e. Master's programs), **PhDs or one-year research stays at a state or state-funded higher education institution in Bavaria**. The one-year scholarship can generally be extended twice for up to 3 years. The scholarship is paid out monthly €934 and amounts to €11.208 per year. EUAA TAKES FIRST STEPS IN IMPLEMENTING €2.8 MILLION GRANTS PROGRAMME FOR 2024-2025

The European Union Agency for Asylum (EUAA) is newly empowered to offer grants! The EUAA has launched a €2.8 million grants programme for 2024-2025, reinforcing its ongoing support for EU Member States in strengthening their asylum and reception systems. This programme is part of EUAA's commitment to enhancing the Common European Asylum System (CEAS) and addressing key operational and reception needs across the EU.

In the 2024-2025, the Agency will prepare **a series of calls for proposals** focused on:

1. **Enhancing its collection of asylum case law:** to enhance the accessibility to, and collection of, jurisprudence relating to asylum – within the context of the Common European Asylum System.
2. **Strengthening its information provision activities:** The Agency currently provides operational support in 11 EU countries; in several countries, providing information to applicants for international protection could be enhanced through grants.
3. **Strengthening support to resettlement:** to create new Resettlement and Support Facilities (RSFs) - important locations for coordinated work between the EUAA and representatives of EU+ countries' resettlement and humanitarian admission programmes.
4. **Enhancing the implementation of the European Asylum Curriculum:** Comprised of 50 different training modules, a future grant will support national capacity to implement the EUAA's European Asylum Curriculum.

The first call for proposals has already been launched targeting universities to enrich EUAA case law database. More will come in 2025.
