MSCA Staff Exchanges

The Staff Exchanges action funds short-term international and inter-sectoral exchanges of staff members involved in research and innovation activities of participating organisations. The aim is to develop sustainable collaborative projects between different organisations from the academic and non-academic sectors (in particular SMEs), based in Europe and beyond.

Exchanged staff benefit from new knowledge, skills and career development perspectives, while participating organisations increase their research and innovation capacities.

Staff Exchanges are open to international consortia of universities, research institutions, businesses, SMEs and other non-academic organisations. They need to include

- at least three organisations in three different countries, two of which need to be located in a different EU Member State or Horizon Europe Associated Country
- above this minimum, the participation of organisations from any country is possible
- if all participating organisations are from the same sector (academic or non-academic), at least one must be from a non-associated Third Country

Staff Exchanges projects can last up to four years. The grant funds the mobility of seconded staff members from one month to one year.

Staff exchanges between organisations in EU Member States or Horizon Europe Associated Countries are required to be between different sectors (academic or non-academic), except if they are interdisciplinary. For partnerships with non-associated Third Countries, exchanges within the same sector and the same discipline are allowed.

Staff funded by Staff Exchanges

- can be researchers at any career stage, from PhD candidates to postdoctoral researchers, as well as administrative, technical or managerial staff involved in research and innovation activities

- can be of any nationality
- must be engaged in, or linked to, research and innovation activities at their sending organisation for at least one month prior to the secondment
- should return to their sending organisation after the secondment, to pass on their knowledge and foster collaboration

MSCA COFUND 2025

MSCA COFUND co-finances new or existing doctoral programmes and postdoctoral fellowship schemes with the aim of spreading the best practices of the MSCA including international, inter-sectoral and interdisciplinary research training, as well as international and cross-sectoral mobility of researchers at all stages of their career.

In practice, MSCA COFUND provides complementary funding for doctoral or postdoctoral programmes managed by entities established in EU Member States or Horizon Europe Associated Countries. Those co-funded programmes must follow MSCA's good practice in terms of international recruitment and minimum standard of employment for the recruited fellows as described in the European Charter for Researchers.

Proposed programmes can cover any research disciplines ("bottom-up"), but exceptionally can also focus on specific disciplines, notably when they are based on national or regional Research and Innovation Strategies for Smart Specialisation (RIS3 strategies). In this case, the range of covered disciplines should allow reasonable flexibility for the researchers to define their topic.

- A) Doctoral programmes
- B) Postdoctoral Programmes

CETP Call 2025

The CETPartnership is a multilateral and strategic partnership of national and regional research, development and innovation (RDI) programmes in European Member States and Associated Countries, aiming to boost and accelerate the energy transition and to support the implementation of the European Strategic Energy Technology Plan (SET Plan).

The CETPartnership is an initiative co-funded by the European Union that brings together public and private stakeholders in the research and innovation ecosystems, from European and non-European countries and regions. CET Partnership aims to foster transnational innovation ecosystems and overcome a fragmented research and innovation landscape.

Brief descriptions of the 2025 calls for proposals, which will open on June 1, 2025, are available. The submission deadline is expected to be in October.

Creative Europe – Culture – Cooperation projects

With a budget of around €60 million, the action will foster cooperation between organisations active in the field of culture, to increase the cross-border dimension of creation and circulation of European artistic content. It will also encourage the development, experimentation, dissemination, and application of new and innovative practices.

The action will support at least 130 projects.

The deadline for applications is 13 May 2025.

European cooperation projects are open to all the cultural and creative sectors. However, considering that this action is part of the Culture strand of Creative Europe, projects with exclusive audio-visual content and/or exclusively composed of organisations from the audio-visual sector are not eligible to apply.

The call covers three (3) topics/categories, depending on the scale of the project(s):

- Small scale: 3 partners, 3 countries, 200 000 EUR max EU grant, 80% EU co-funding
- Medium scale: 5 partners, 5 countries, 1 000 000 EUR max EU grant, 70% EU co-funding
- Large scale: 10 partners, 10 countries, 2 000 000 EUR max EU grant, 60% EU co-funding

COST - European Collaboration in Science and Technology

Participants are invited to submit COST Action proposals contributing to the scientific, technological, economic, cultural or societal knowledge advancement and development of Europe. Multi- and interdisciplinary proposals are encouraged.

The funding a COST Action receives covers the expenses of networking activities rather than research. As such is used to organise and fund events, Short-term Scientific Missions, Training Schools, communication activities, and virtual networking tools. An estimated €125,000 is made available for a COST Action in its first year and an average of €150,000 per year for the other 3 years.

Deadline: 21. October 2025.

Participation in COST Actions has led to significant results and follow-up in terms of the number of proposals submitted for collaborative research in Framework Programmes, with a success rate which more than triple the average success rates for these programmes (37% success rate). By funding networking, COST acts as a pre-portal for further research and innovation funding such as Horizon Europe, the European Union's Framework Programme for Research and Innovation.

Wellcome Foundation - Climate Impacts Awards: Unlocking urgent climate action by making the health effects of climate change visible

The aim of this scheme is to make the impacts of climate change on physical and mental health visible to drive urgent climate policy action at scale. Wellcome Foundation will fund transdisciplinary teams to deliver short-term, high-impact projects that maximise policy outcomes by combining evidence generation with influencing and engagement strategies.

In scope:

- Proposals where the primary focus is on the current or future direct and environmentally mediated physical or mental health outcomes attributable to climate change (Haines and Ebi 2019 for definitions), making the health effects of climate change visible
- Proposals that include the three key elements of:
 - an evidence gap that can be filled in the short time available
 - a clear policy pathway to influence change
 - an engaged research approach with key stakeholders identified (including a communication strategy)

Lead applicant career stage: mid-career researcher, established researcher;

Administering organisation location: anywhere in the world (apart from mainland China);

Funding amount: up to 2.5 million GBP;

Funding duration: up to 3 years;

Coapplicants: accepted.

Visegrad Grants -Visegrad Grant, Visegrad Grant+, Strategic Grant

Visegrad Fund annually allocates approximately EUR 10 million to hundreds of Visegrad cooperation projects and mobility programs across Central and Eastern Europe. The project should be implemented in a consortium.

Visegrad Grant

The international consortium should be composed from at least 3 V4 countries OR Bilateral cross-border cooperation of at least 2 organizations from 2 neighboring V4 countries also qualify for support with projects taking place within a 40-km radius from the border and focusing on a local issue.

Projects must address at least one of the objectives of the grant program's seven focus areas: Culture and Common Identity; Education and Capacity Building; Innovation, R&D, Entrepreneurship; Democratic Values and the Media; Public Policy and Institutional Partnership; Regional Development, Environment and Tourism; Social Development.

Visegrad Grant+

Active involvement of at least 3 V4 countries and 1 entity from the Eastern Partnership region (EaP) or the Western Balkans countries (WB) at minimum (3xV4 + 1xEaP/WB format). However, if the applicant is from one of the EaP or WB countries, it is enough to involve two V4 countries in the project consortium, if another EaP/WB country is also involved (2xV4 + 2xEaP/WB format).

Projects must address at least one of the objectives of the grant program's seven focus areas: Culture and Common Identity; Education and Capacity Building; Innovation, R&D, Entrepreneurship; Democratic Values and the Media; Public Policy and Institutional Partnership; Regional Development, Environment and Tourism; Social Development.

Strategic Grant

Projects must be developed by organizations from all V4 countries.

Projects must clearly address one of the annual strategic priorities of the Visegrad Group. Strategic priorities in 2025: Promoting volunteering in the V4 region, Promoting shared values, Supporting water management and flood protection cooperation in the region.

Although Visegrad, Visegrad+ and Strategic Grants have no strict limitation for the size of the financial support you can apply for, the average project budget does not exceed €30.000. Each submitted proposal is evaluated on its merit, taking into account the potential outreach and impact of the project, the elaboration of the grant budget in the "Outputs" section and adherence to the "value-for-money" principle.

Leakey Foundation Research Grants

Our current funding focus areas include:

- Paleoanthropology of the Miocene, Pliocene, and Pleistocene

Who can apply

- PhD students must be advanced to candidacy (all but dissertation).
- There are no citizenship requirements. Applications are open to candidates from anywhere in the world.
- Applicants must be affiliated with an institution such as a university or museum. We do not give directly to individuals.
- Resubmittals are welcome and encouraged.
- If you have received a Leakey Foundation grant in the past, you must complete all reporting requirements before receiving a new one.

Eligible expenses

- The grant can only be used for expenses directly related to your research and essential to the project such as travel, living expenses during fieldwork, supplies, and research expenses.
- Aid is not offered for salary and/or fringe benefits of applicant or senior project personnel, child care, equipment, travel to meetings, institutional overhead, publication costs, or institutional support.

Federation of European Biochemical Societies (FEBS) fellowships

The FEBS Fellowships programme is a highly competitive and respected programme for early-stage researchers. Most of its schemes over the years have supported graduate students and early-career researchers in the molecular life sciences in the FEBS area to move to and carry out a period of research in a lab in a different FEBS country, thus broadening their experience and training, giving access to additional research techniques and expertise, and facilitating international collaboration.

Types of FEBS fellowships:

- Short-Term Fellowships are for scientists who have obtained their PhD degree within the past six years, and PhD students who have at least one published paper as a main author in an international scientific journal. Applications may be made at any time, but an application should be submitted at least three months before the proposed starting date
- Summer Fellowships are for PhD students and Master's students. Apply by 1 April each year (the call normally opens in February).
- Ukrainian Short-Term Fellowships are for active molecular life scientists from Ukraine who have a PhD. Apply any time.

The AGA serves as a guide to the Model Grant Agreement (MGA), the standard document for contracts concluded between the European Commission or its executive agencies and beneficiaries supported under EU programmes. The AGA illustrates each article of the MGA with explanations and examples.

The details of the update are listed in the ‘History of changes’ (p.4 of the AGA), with the new changes in substance marked with green square.

Please note that it includes updates of cross-references to the new EU Financial Regulation 2024/2509 (recast) and includes new clarifications under Articles 6.1 and 6.2.A, amongst other provisions.

Shaping the future of the EU together: the Commission sets out the road to the next EU long-term budget

The European Commission published a Communication on ‘The Road to the next Multiannual Financial Framework’. It outlines the key policy and budgetary challenges that will shape the design of the next Multiannual Financial Framework (MFF). This lays the groundwork for reflections on how to adapt the EU’s long-term budget to evolving needs and priorities. With this Communication, the Commission also launches in parallel a Europe-wide campaign with a range of stakeholders, including Member States governments, regional entities, and citizens.

The EU budget benefits all Europeans, and they should have the opportunity to express their views on the future of the EU budget. That is why the Commission launches a public consultation inviting stakeholders and citizens to have their say on the future EU budget and the policies it should support.
